

# Terms and Conditions, Consent Form, and Privacy Policy for the EFB Elektronik GmbH Contest

By entering our contest, you agree to the following terms and conditions:

## 1. Organizer

The contest is organized and conducted by us, EFB Elektronik GmbH, Striegauer Str. 1, 33719 Bielefeld, registered with the Bielefeld Commercial Register (AG Bielefeld) under HRB 33008, with Robin Ohle and Nana Heinemann serving as managing directors (= "Organizer").

## 2. Contest Period and Participation

The 2026 FIFA World Cup contest begins on June 11, 2026, at 12:00 a.m. and ends on July 19, 2026, at 11:59 p.m. ("Contest Period"). Participation is only possible during the Contest Period.

Participation in the contest requires registration on the provided Kicktipp platform at <https://www.efb-elektronik.de/en/world-cup-2026>. Participants must properly complete the registration form on the platform using their company email address. After registration, predictions for the individual matches as well as the championship prediction must be submitted in accordance with the platform's guidelines and within the deadlines specified in the "Rules of the Game." The Rules of the Game and the timeframe for submitting predictions are available directly on the Kicktipp platform.

Points for correctly submitted predictions are awarded automatically by the platform. The winner is determined based on the highest score in the automatically generated leaderboard. Only individuals who meet the requirements set forth in Section 3 and are not excluded from the contest pursuant to Section 4 are eligible to participate.

Participation in the contest is free of charge and voluntary. Each eligible person may participate only once. There is no legal entitlement to participate in the contest.

## 3. Eligible Participants and Excluded Persons

Participation in our contest is only permitted if the participant is at least 18 years of age and is an employee of one of our existing or new customers at the time the contest is held (= "Eligible Participants").

Our employees and their relatives are excluded from participating in the contest.

## 4. Exclusion from Participation, (Retroactive) Revocation of Prizes, and Return of Prizes

We reserve the right to exclude participants from the contest who gain an advantage through manipulation or violate these terms and conditions. In such cases, the prize may be revoked retroactively, and a replacement winner may be drawn.

In the event of revocation of the prize, the participant is obligated to return the prize to us immediately.

## 5. Prize Drawing

Five winners will be selected. The prize drawing will take place on July 22, 2026, without notarial supervision.

## 6. Notification of Winners and Replacement Drawing

Winners will be notified of their prize via email after the contest has ended.

If a winner does not respond to the prize notification within 30 days, the prize will be forfeited and a replacement winner will be drawn.

### **7. Prize Delivery, Restrictions, and Taxes**

We will send the prize only to the management of our client. Participants are therefore required to inform their employer in advance of their participation in this contest.

Cash payment, modification, or exchange of the prize is not permitted. Prize claims are non-transferable.

Please note that the prizes awarded in this contest constitute income and are taxed by us in accordance with the flat-rate taxation provision of § 37b of the German Income Tax Act (EStG). The winners are therefore not required to pay additional taxes on the prizes received.

### **8. Consent to Marketing Activities**

We reserve the right to use any images, photographs, film, or video recordings of the winners taken during the prize presentation for advertising and/or public relations purposes (e.g., the Internet, brochures, flyers, etc.) without limitation on print run, and without restriction as to time or location, and free of charge.

By participating in this contest, the participant(s) agree(s) to this.

### **9. Liability**

Our liability—regardless of the legal basis—is excluded. This also applies in the event of technical malfunctions during registration, data transmission, or data processing.

### **10. Data Protection**

Personal data provided to us through participation in the contest will be treated confidentially and in accordance with applicable data protection laws. It will be used, stored, and processed exclusively in connection with this contest and in accordance with these Terms and Conditions.
