

Conditions of participation, consent and privacy policy for the EFB Elektronik GmbH competition

By participating in our competition, you agree to the following terms and conditions:

1. Organizer

The competition is operated and organized by us, EFB Elektronik GmbH, Striegauer Str. 1, 33719 Bielefeld, Commercial Register AG Bielefeld HRB 33008, Managing Directors Robin Ohle and Alexander van der Lof, (= "Organizer").

2. Prize duration and participation

The competition for the European Football Championship 2024 begins on May 14, 2024 at 0:00 am and ends on July 14, 2024 at 11:59 pm ("Competition Period"). Participation is only possible during the Prize Draw Period.

Participation in the competition is via registration on the Kicktipp platform <https://www.efb-elektronik.de/en/euro-2024/kick-tip>. Participants must duly complete the registration form on the platform with their real name and company e-mail address. After registration, the tips for the individual matches and the championship tip must be submitted in accordance with the platform's specifications and within the deadlines specified in the "Rules of the Game". The rules of the game and the time frame for submitting bets can be viewed directly on the Kicktipp platform.

Points are awarded automatically by the platform for correctly submitted tips. The winner will be determined by the highest number of points in the automatically generated ranking list. Only persons who meet the requirements set out in section 3 and are not excluded from the competition in accordance with section 4 are eligible to participate.

Participation in the competition is free of charge and voluntary. Each eligible person may only participate once. There is no legal entitlement to participate in the competition.

3. Eligible and excluded participants

Participation in our competition is only possible if the participant is over 18 years of age and is an employee of one of our customers or new customers at the time of the competition period (= "eligible participants").

Our employees and their relatives are not eligible to take part in the competition.

4. Exclusion from participation, (subsequent) prize rejection and prize return

We reserve the right to exclude participants from the competition if they gain an advantage through manipulation or violate these conditions of participation. In such cases, the prize may also be subsequently withdrawn and a replacement winner drawn.

In the event of the prize being withdrawn, the participant is obliged to return the prize to us immediately.

5. Prize draw

10 winners will be determined. The prize draw will take place on 17.07.2024 under non-notarial supervision.

6. Notification of winners and replacement draw

The winner(s) will be informed of the prize by email after the competition has ended.

If a winner does not respond to the prize notification within 30 days, the prize will be forfeited and a replacement winner will be drawn.

7. Profit transfer, limits and taxes

We will only send the prize to the attention of our customer's management. Participants are therefore obliged to inform their employer in advance of their participation in this competition.

A cash payment, change or exchange of the prize is not possible. Prize claims are not transferable.

We would like to point out that the benefits of this competition constitute income and will be taxed by us in accordance with the flat-rate regulation of § 37b EStG. The winners therefore do not have to pay tax on the winnings received.

8. Consent to marketing activities

We reserve the right to use any images, photographs, film or video recordings of the winners at the prize presentation for advertising purposes and/or public relations work (e.g. Internet, brochures, flyers, etc.) without restriction in terms of time and space and free of charge.

By participating in this competition, the participant(s) agree(s) to this.

9. Liability

Our liability - for whatever legal reason - is excluded. This also applies in the event of technical faults during registration, data transmission or processing.

10. Data protection

Personal data transmitted to us through participation in the competition will be treated confidentially and in accordance with the statutory data protection regulations. They will only be used, stored and processed in connection with this competition and in accordance with these conditions of participation.
