

Conditions of participation, agreement and privacy policy

for the Christmas contest of EFB Elektronik GmbH

By participating in our raffle you agree to the following conditions:

1st organizer

The raffle is operated and carried out by us, EFB Elektronik GmbH, Striegauer Str. 1, 33719 Bielefeld, commercial register AG Bielefeld HRB 33008, managing director Robin Ohle and Alexander van der Lof, (= "organizer").

2. Winning time and participation

The raffle will begin on December 5, 2017 at 0:00 am and end on December 21, 2017 at 11:59 pm (= "winning time"). Only within the playing time is the participation in the raffle possible.

The participation in the raffle takes place by completing the appropriate participation form on our website www.efb-elektronik.de and a simultaneous order via our fiber optic configurator and / or a request via our fiber optic configurator which leads to a binding order (= "Participation "). If the entry form is completely and duly completed and a binding order within the winning period as shown, the person participates in the raffle, provided that they acc. Paragraph 3 is eligible and not acc. Number 4 was excluded from the raffle.

Each person may only participate once in the raffle.

There is no entitlement to participation.

Incidentally, participation in the raffle is free of charge and voluntary.

3. Eligibility and Excluded Persons

Participation in our raffle is only possible if the participating person has reached the age of 18 and are employees of one of our customers or new customers at the time of the winning period (= "Eligible").

Our employees and their relatives are excluded from participating in the raffle.

4. Disqualification, win disallowed and return of the win

We reserve the right to exclude participants from participating in the Sweepstakes, who gain advantage through manipulation or are in breach of these terms and conditions. In these cases, the profit can also be subsequently revoked and a (e) replacement winner (in) will be drawn.

In the case of the withdrawal of profit, the participant is obliged to return the prize immediately to us.

5th prize draw

There will be three winners. The prize draw takes place on 11.01.2018 under non-notarial supervision.

6. Notification of winners and substitute raffle

The winners will be informed of the prize by e-mail after the competition has ended.

If a winner does not respond to the winning notification within 30 days, the prize will be forfeited and a substitute winner will be drawn.

7. Win hand out, limitations and taxes

The profit is sent by us only to the management of our customer. The participant is therefore obliged to inform his employer about participation in this competition beforehand.

A cash payment or an exchange of the prize is not possible. Profit entitlements are not transferable.

It should be noted that the benefits of this competition represent income and are taxed by us in accordance with the lump-sum provision of § 37b EStG. The winners therefore do not have to pay tax on the profits they have received.

8. Consent to marketing measures

We reserve the right, if necessary, created images, photography, film or video recording of the winners in the profit transfer for advertising purposes and / or public relations (eg Internet, brochures, flyers, etc.) without limitation of the circulation time and space unlimited and to use free of charge.
